

## **GLOSSARY OF DECEPTIVE TERMS**

The following definitions for the terms listed below are what sexual rights advocates and comprehensive sexuality education (CSE) advocates often mean when they use these terms. These definitions do not necessarily reflect what these terms should mean.

Term	Definition
Abortion, Legal/Illegal	Illegal abortion is always defined to mean unsafe abortion, and legal abortion to be always safe, regardless of the circumstances or the safety of the procedure
Abortion, Safe/Unsafe	Safe abortion = legal abortion, Unsafe abortion = illegal abortion, used to pressure countries to legalize abortion
Abstinence	Anything goes, including petting, masturbation, rubbing genitals, etc., as long as there is no penetration
Abstinence Education	Fear-based, unscientific, religious instruction on sexuality that shames youth for having sex and promotes homophobia and transphobia. Denies youth the right to sexual information (including information on condoms and abortion).
Access (Give access to)	Note: Often interpreted to imply a right to something. For example "universal access to sexual and reproductive health" can be construed to be a right to SRH. It also can be implied that all legal restrictions must be removed. Often used in the context of sexual information for children or sexual and reproductive health services, interpreted to "include abortion or CSE without parental knowledge or consent."
Age-Appropriate	This is a term designed to trick people into accepting CSE, giving a false sense of security that somehow CSE becomes sanitized if this is added when in reality, CSE is never appropriate.

Gender Role	Traditional stereotyped roles for males and females
Gender Sensitive	LGBTQI sensitive
Gender Stereotypes	Traditional stereotyped depictions of males and females and/or their roles
Gender Transformative	LGBTQI transformative
Gender Variant	Transgender-identified person
Gender-Based Violence	Violence against LGBTQI people, especially transgenders
Give Access	Ensure government funds for and removal of any legal restrictions
Global Citizenship	LGBTQI affirming behavior
Harmful Gender Norms	Religious beliefs
Harmful Practices	Religious practices and beliefs with rigid sexual standards
Health Rights	Any claimed "sexual rights" listed under "sexual rights" below
Healthy Relationships	Sexual relations where pleasure is equally experienced and sex is uninhibited
Healthy Sexuality	Sexuality that encompasses diverse, pleasurable sexual experiences; acceptance of LGBTQI sexual acts and identities; uninhibited sex
HIV/AIDS Prevention Education	Comprehensive Sexuality Education
