

# SEND 'WAR ON CHILDREN' VIDEO to State School Board Members

## BACKGROUND:

On 3-11-21, the Nebraska Department of Education (NDE) released Draft #1 of it recommended Health Standards for curricula to be taught to elementary – middle – high schools children. NDE asked parents across Nebraska to review their Draft #1 and provide feedback to NDE via an on-line survey. The majority of parents who reviewed the standards were appalled and angered at the sexually explicit and harmful materials contained in the proposed Comprehensive Sexuality Education materials. Parents were also opposed to the Critical Race Theory materials that were contained in the Draft #1 standards.

Over 4,000 emails were received by the NDE and many of the eight Nebraska State Board of Education members received 100 or more emails from concerned parents. A large crowd of concerned parents filled the Marriott Courtyard Hotel in Lincoln on 4-2-21 and testified at the State Board of Education meeting. Here are the stats from our in-person opposition efforts at the 4-2-21 Nebraska Board of Education meeting in Lincoln:

- A. 83 Total Testifiers
- B. 66 Opposition Testifiers (80%)
- C. 17 Proponent Testifiers (20%)

This document contains our next state-wide action step to educate Nebraska School Board of Education members so that they vote NO on every draft of Health Standards that contain Comprehensive Sexuality Education or Critical Race Theory materials.

## IMPORTANT NOTE:

Omaha Public Schools is already teaching CSE curricula called the 3Rs – Rights, Respect, & Responsibility. We don't want any more Nebraska children exposed to these harmful materials!

3. Email a short letter with the 'War on Children' link to your Nebraska State School Board Member. Reference attached map & list of State School Board members with contact information. Share these 3 key thoughts in your email:
  - A. You were shocked to learn about the world-wide plan to sexualize children
  - B. You know that sexualization of children is actually grooming them for sexual exploitation
  - C. I'm asking you to invest 11 minutes to watch this video and learn the facts as I did about Comprehensive Sexuality Education.
  - D. Please call me or email me your answer to these four questions:
    - a. "Did you already know about this world-wide plan from the UN to sexualize all children?"
    - b. "Did you realize that a key source used by the Nebraska Department of Education in writing the Draft #1 of Health Standards was the Standards written by SIECUS -- Sexuality Information & Education Council of the United States?"

- c. *“Did you know that SIECUS has direct ties to Planned Parenthood, one of the largest providers of contraceptives and abortions in the world?”*
  - d. *The vast majority of Nebraska parents DO NOT WANT CSE or Critical Race Theory taught to their children. What specific actions will you take to ensure that Draft #2 and the final Draft of the proposed NDE Health Standards are totally void of Comprehensive Sexuality Education and Critical Race Theory material?*
4. Forward this information to your conservative circle of influence. Ask them to invest the 30 minutes required to perform Steps 1 – 2 – 3.
  5. Pray for Divine Intervention to reign to protect the health and innocence of Nebraska’s children.
